The Data Protection Policy is issued by PU Prime LLC (the “Company”, “we”, “us”, or “our” as appropriate), in keeping in compliance with the Data Protection Act (“DPA”) of Saint Vincent and the Grenadines.

PU Prime is the commercial name of PU Prime LLC, which is authorised and regulated by the Financial Services Authority of Saint Vincent and the Grenadines under number 271 LLC 2020. The Company is registered in St. Vincent and the Grenadines and located at Euro House, Richmond Hill Road, Kingstown, VC0100, Saint Vincent and the Grenadines, P.O. Box 2897.

1. Scope

The Company is committed to protecting and safeguarding the privacy, confidentiality and security of all individuals personal information. This does not only include its clients, but all employees, suppliers and any other individuals it may conduct business with. It is also the responsibility of all PU Prime employees to comply with the regulatory requirements.

2. Personal Information

For this Data Protection Policy, (a) references to “personal information” include “personal data” where such terminology is used under applicable law; and (b) personal information that you provide in connection with registering as a user of our website or services is referred to as “Registration Information”.

- (i) identity information, such as your full name, date of birth, place of birth, and nationality;
- (ii) contact information, such as your email address, phone number, and residential address;

- (iii) identity verification documents, such as a certified copy of your national ID card, passport, or other government-issued identification, and proof of address (e.g., a recent utility bill);
- (iv) financial information, such as your bank account details, credit or debit card information, other payment method details, source of funds, annual income, and occupation;
- (v) tax information, such as your Tax Identification Number (TIN) and country of residence;
- (vi) transaction and account data, such as your deposit and withdrawal history, details of financial instruments and funds held on your behalf, and records of transactions conducted;
- (vii) technical and usage data automatically collected when you visit our website or use our services, such as your Internet Protocol (IP) address, device identifiers, browser type and settings, geolocation information, pages visited, frequency and duration of visits, referring URLs, and your website activity;
- (viii) correspondence data, such as records of communications between you and PU Prime, including chat logs and call recordings where applicable; and
- (ix) any other personal information you voluntarily provide to us or that we are otherwise required or permitted to collect under applicable laws and regulations.

Below sets out information we are required to obtain, how such information is process and stored.

1. PU Prime will request for your email address which will be used to send all necessary notifications provided on our website to ensure compliance with any laws, guidelines or requests issued by the authorities.
2. Failure to provide such data to PU Prime may result in being unable to open an account and to be provide the notification services to you or to comply with any laws or guidelines issued by the authorities.
3. Personal information collected and/or held includes information that you provide to us during the account opening process such as your personal details, contact information and communication records i.e. inquiries and our responses.

4. Personal information collected by PU Prime (whether provided by you or any other person on your behalf) may be used by PU Prime for providing notification services to you.

Third Party Management

All personal data collected by PU Prime relating to you will be kept confidential, however, PU Prime may provide such information (whether provided by you or any other person on your behalf) to the following parties, within or outside of Saint Vincent and the Grenadines, for the purposes set out in the DPA:

- any director, officer, employee of PU Prime or affiliates of PU Prime only when carrying out their respective business activities;
- any professional advisor, insurer or auditor of PU Prime or their affiliates;
- any third party with which you have or propose to have dealings;
- any person to whom PU Prime transfers, assigns or proposes to transfer or assign its interests and/or obligations in respect of the account or any services provided to you;
- any person to whom PU Prime is required by law, regulation, court order or request from any governmental or regulatory body to provide such data.

Cookies

Cookies are small bits of information that are stored on your computer and that can be accessed by our website. PU Prime may use cookies to record your visit to our website for analysing the number of visitors, general usage patterns and your personal usage patterns and improving your experience. Furthermore, PU Prime may set and access cookies on your computer in order that we are able to recognize your device and to retrieve information about your use of our website, enabling us to provide more useful features to you, to tailor the content of our website to suit your interests and, where permitted, provide you with promotional materials or direct marketing based on your usage patterns. You may opt not to accept cookies however you may not be able to

utilize our website and its features fully. If you accept cookies, you acknowledge and agree that your information is being collected, stored, accessed and used as stated above.

Transfer

PU Prime may from time to time transfer your personal data outside the St. Vincent and the Grenadines for any of the purposes set out in paragraph 5 of this notice including data processing and/or storage.

As clients of PU Prime, you have the right in accordance with the DPA to:

- check or enquire whether PU Prime holds personal data about you;
- request access to any such personal data held by PU Prime within a reasonable time, in a reasonable manner and in a form that is intelligible;
- request the correction of your personal data which is inaccurate; and
- ascertain PU Prime's policies and practices in relation to data and to be informed of the kind of personal data held by PU Prime;

9. Nothing in this notice shall limit the rights of the client under the DPA.

Changes in this Data Protection Policy

If we decide to change our Data Protection Policy, we will post those changes to this Data Protection Policy, on our website, and other places we deem appropriate so that you are aware of what information we collect, how we use it, and under what circumstances, if any, we disclose it.

We reserve the right to modify this Data Protection Policy at any time, so please review it frequently. If we make material changes to this policy, we will notify you here, by email, or by means of a notice on our website.
